DISCUSSION

a. Introduction of Deputy Town Clerk

Town Clerk Heather Smith introduced Brittney Hunt, the new Deputy Town Clerk.

b. Strategic Implementation Plan Update

Town Manager Bill Summers provided background information on the Annual Implementation Plan that outlines capital investments and initiatives that the Town Council will accomplish in a fiscal year.

Mr. Summers identified goals for the Connected and Inclusive focus area that include hosting a local government career fair, local government job shadow day, and Knightdale Future Leaders Academy for high school and college students.

c. River District Kick-Off

Development Services Director Jason Brown introduced Senior Planner Donna Goodman who summarized the geographic boundaries of the proposed Knightdale River District, provided a timeline of events, and highlighted plan elements such as the study area, planning process, transportation, environmental impacts, and recommendations.

Ms. Goodman mentioned key components of the proposed River District, discussed conceptual catalyst sites, and reviewed transportation and land use elements related to the district.

Ms. Goodman provided ideas and imagery for the proposed district and summarized next steps in the process, including stakeholder meetings and inperson and online public outreach.

Ms. Goodman asked for Council input and direction towards policy statements, design guidelines and standards, and future land use.

Council discussed Bus Rapid Transit, walkability, land use, pedestrian lighting, artwork, signage, recreation and amenities, business integration, branded identity, and multi-use paths.

Mr. Brown answered questions from Council in reference to development bordering Knightdale and expectations of recently approved developments.
