3. JOINT PUBLIC HEARINGS

a. ZMA-11-22 Weldon

Public Hearing opened at 7:03 p.m.

Senior Planner Kevin Lewis presented ZMA-11-22, a request to rezone 41 acres located at Horton Road and Old Knight Road from Rural Residential-1 to Residential Mixed-Use Planned Unit Development to develop 146 residential units and 15,000 square feet of commercial space.

Mr. Lewis shared the vicinity map, site profile, surrounding area uses, master plan, project timeline, and provided a site plan analysis highlighting environmental features, buffers, open space, and parking.

Mr. Lewis discussed the proposal's compliance with the town's water allocation policy, reviewed the proposed site development allowances, architectural standards, and architectural elevations.

Mr. Lewis highlighted the proposal's consistency with the KnightdaleNEXT Comprehensive Plan, Strategic Plan, and Parks and Recreation Master Plan and answered questions from Council and Land and Use Review Board members.

Brian Richards, 150 Fayetteville Street Raleigh, representing Urban Design Partners, elaborated on the master plan highlighting open space and amenities, a commercial outparcel, and architecture.

Jay Colvin, 4009 Periwinkle Blue Lane Raleigh, representing the applicant, answered questions from Council.

Assistant Town Manager Suzanne Yeatts summarized a written comment from the following individual:

b. ZMA-12-22 Haven at Griffith Meadow

Public Hearing opened at 7:41 p.m.

Senior Planner Kevin Lewis presented ZMA-12-22, a request to rezone 60.15 acres located at 8613 Poole Road from Rural Transition to General Residential-3 Planned Unit Development to develop 180 residential units.

Mr. Lewis shared the vicinity map, site profile, surrounding area uses, master plan, project timeline, and provided a site plan analysis highlighting buffers, landscaping, open spaces, parking, utilities, and jurisdiction and town services.

Mr. Lewis reviewed the transportation analysis recommendations, the proposal's compliance with the water allocation policy, and summarized the applicant's proposed site development allowances, architectural standards, and elevations.

Mr. Lewis discussed the proposal's consistency with the KnightdaleNEXT Comprehensive Plan, Strategic Plan, and Parks and Recreation Master Plan and answered questions from Council.

Brett Hanna, 301 Hillsborough Street Raleigh, Andrew Suriano, 4300 Lambeth Drive Raleigh and Beth Blackman, 5410 Trinity Road Suite 102 Raleigh, representing the applicant, spoke about the project, noted this would be their first project in Knightdale, and shared they were available to answer questions.

c. ZMA-1-23 NCDOT Cell Tower Relocation

Senior Planner Kevin Lewis presented ZMA-1-23, a request to rezone 15.54 acres located at 7417 Poole Road from Neighborhood Mixed Use (NMX) to Rural Residential-1 (RR1) to allow for the future relocation of a wireless telecommunication tower.

Mr. Lewis shared the vicinity map, site profile, surrounding area uses, permitted uses, master plan, and project timeline and highlighted the proposal's consistency with the KnightdaleNEXT Comprehensive Plan.

Nishka Hatten, 421 Fayetteville Street Raleigh, representing the applicant, spoke about the project.

- Chapter 15 Definitions

Mrs. Goodman answered questions from Council and Land Use Review Board members.
