b. Facilities Funding Strategy Update

Finance Director Mark Stephens provided an update on funding strategies for the Mingo Creek Greenway Extension and Forestville Road Fire Station.

Mr. Stephens discussed debt impacts of each project, shared how the town's internal debt service policy compares to neighboring communities, and answered questions from Council.

Council discussed increasing the debt service policy from 11% to 15%.

Mayor Day and Assistant Town Manager Suzanne Yeatts informed Council that a few local legislators have inquired about providing support for town projects. Staff will provide the legislators with a list of upcoming projects.

c. Monthly Development Services Update

Senior Planner Kevin Lewis provided an update on current residential development and discussed historical trends in development.

Senior Planner Gideon Smith discussed Lyndon Oaks, a project in the sketch plan stage, and answered questions from Council.

Mr. Lewis provided updates on Robertson Crossing, a project in the master plan stage, and answered questions from Council.
