3. JOINT PUBLIC HEARINGS

a. ZMA-15-22 Parkside at Westlake

Public hearing opened at 7:02 p.m.

Senior Planner Kevin Lewis presented ZMA-15-22, a request to rezone 206.48 acres located at 4001 South Smithfield Road from Wake County's Residential-30 (R-30) and Residential-10 (R-10) to Neighborhood Mixed-Use Planned Unit Development (NMX-PUD) to develop 1158 residential units and up to 250,000 square feet of retail and office space.

Mr. Lewis reviewed the vicinity map, site profile, zoning and surrounding area land uses, jurisdiction, master plan, project profile, and project timeline. He shared a site plan analysis, highlighting buffers, environmental features, open spaces, parking, mini-storage facility, multi-family units, commercial center, and phasing.

Mr. Lewis provided an overview of the transportation analysis, discussing street infrastructure, connections to existing and proposed developments, pedestrian access, and greenway infrastructure. He summarized the intersections studied in the transportation analysis, noting that NCDOT review is ongoing.

Mr. Lewis reviewed water allocation policy requirements, site development allowances requested by the developer, and proposed architectural elevations.

Mr. Lewis discussed the proposal's consistency with the KnightdaleNext Comprehensive Plan, Strategic Plan, and the Comprehensive Parks and Recreation Master Plan and answered questions from Council about the future growth framework map.

Mayor Pro Tem McDonald commented on landowner rights, clarifying that the project was developer and landowner initiated.

Katie Hamilton, 2310 S. Miami Blvd Durham, NC, representing the applicant, spoke in favor of ZMA-15-22, sharing why Knightdale is the preferred location, highlighting development design, discussing on-site drainage, and answering questions from Council related to transit.
