**RESOLUTION FIXING A DATE OF PUBLIC HEARING ON QUESTION OF**  
**ANNEXATION PURSUANT TO NCGS §160A-31**

**WHEREAS**, a petition requesting annexation of the area described herein has been received, and

**WHEREAS**, the Town Council has directed the Town Clerk to certify sufficiency of said petition.

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Knightdale, North Carolina:

**Section 1.** A public hearing on the question of annexation of the area described herein will be held at 7:00 pm on the 17<sup>th</sup> day of December 2025.

**Section 2.** The area proposed for annexation is described as follows:

**Legal Description**

Beginning at a new iron pipe, said new iron pipe being located on the western right-of-way of Clifton Road (S.R.#2601), said new iron pipe having NC Grid NAD 83' (2011) coordinate n(y):734,002.28' e(x):2,148,470.12'; thence n 87°09'50"e a distance of 31.05' to a point, said point being the centerline of Clifton Road; thence along centerline s 17°46'28"e a distance of 262.75' to a point; thence s 17°46'28"e a distance of 512.57' to a point; thence leaving Clifton Road centerline s 77°54'21"w a distance of 30.15' to an existing iron pipe; thence leaving Clifton Road right-of-way s 77°54'21"w a distance of 269.92' to a bent existing iron pipe; thence s 03°24'02"e a distance of 206.37' to a new iron pipe; thence s 87°22'34"w a distance of 1,266.00' to an existing iron pipe, said existing iron pipe having NC Grid NAD 83' (2011) coordinate n(y):732,938.62' e(x):2,147,191.98'; thence n 02°46'17"w a distance of 999.49' to a bent existing iron pipe; thence n 87°11'15"e a distance of 1,020.16' to an existing iron pipe; thence n 87°09'50"e a distance of 307.92' to a new iron pipe; which is the point of beginning, containing an area of 1,419,747 square feet, 32.593 acres.

**Section 3.** Notice of said public hearing shall be published in the Wake Weekly, a newspaper having general circulation in the Town of Knightdale, at least ten (10) days prior to the date of said public hearing.
