04/15/26 (4/8 Agenda Deadline)	<u>COUNCIL ACTION:</u> Town Council of the Town of Knightdale (the “ <i>Council</i> ”) adopts (1) Resolution directing publication of notice of intent to apply to the Local Government Commission (the “ <i>LGC</i> ”); (2) Resolution authorizing the Finance Director to apply to the LGC and making certain findings of fact
04/17/26	Publish Notice of Intent in newspaper of general circulation [must wait 10 days after publication of Notice of Intent before applying to LGC]
04/28/26	File Application with LGC and prepare Sworn Statement of Debt
by 05/19/26	Receive Letter of Acceptance of Application requesting approval of LGC [must receive letter before Bond Order is introduced]
05/20/26 (5/13 Agenda Deadline)	<u>COUNCIL ACTION:</u> Board (1) introduces Bond Order and (2) adopts the Resolution setting a public hearing on the Bond Order
by 06/10/26	Publish Public Hearing Notice on the Bond Order with newspaper of general circulation [at least 6 days before public hearing]
After 05/20/26, before 06/17/26	Finance Director files (1) Sworn Statement of Debt and (2) Statement of Disclosure with the Town Clerk; Statement of Disclosure also to be filed with LGC, posted online, and maintained by the Town Clerk
06/17/26 (6/10 Agenda Deadline)	<u>COUNCIL ACTION:</u> Council (1) holds public hearings on the Bond Order; (2) adopt Bond Order; and (3) adopts Resolution setting a Special Bond Referendum
06/18/26	Publish Bond Order as adopted in newspaper of general circulation
by 06/20/26	Town Clerk delivers certified copy of Resolution setting a Special Bond Referendum to the Wake County Board of Elections [within 3 days of adoption of Resolution setting a Special Bond Referendum]
07/17/26	Wake County BOE Ballot Printing Deadline
09/25/26	Town sends Notice to Joint Legislative Committee on Local Government
by 09/25/26	Publish first Notice of Special Bond Referendum in newspaper of general circulation [not less than fourteen days before last day to register to vote for Bond Referendum]

by 10/02/26	Publish second Notice of Special Bond Referendum in newspaper of general circulation [not less than seven days before last day to register to vote for Bond Referendum]
10/09/26	Last day to register to vote
11/03/26	Referendum
by 12/10/26	State Board of Elections adopts Certificate of Results and sends Certificate to Wake County Board of Elections to provide to the Town
12/16/26	<u>COUNCIL ACTION:</u> Council adopts Resolution Certifying and Declaring Results of Special Bond Referendum
12/17/26	Publish Statement of Results in newspaper of general circulation
01/05/27 ¹	LGC approval of bond order
